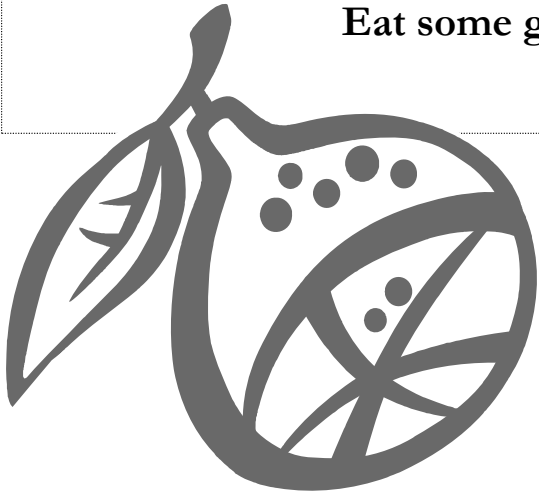


Friday, March 25th—You be the Judge!
